- 1) Board Meeting called to Order 6:33pm
 - a. Nancy Zimmer, Walt McDonald, Felicia Erskine, George Platica and Vince Montelione present. Andre Hardy absent. Quorum is certified.
 - b. Lee Lazerson of Oasis Community Management present
- 2) Vickie Hooke resigned with the sale of her home. Board accepts her resignation.
- 3) Nancy motions to appoint Vince Montelione Secretary. Walt seconds. Unanimous approval.
- 4) Vince motions to approve board meeting minutes from March 17, 2022 meeting. Felicia seconds. Unanimous approval.
- 5) Lee provides financial update
 - a. Through April 30 YTD, association has a net surplus of \$56,034.07.
 - b. Centennial Operating Account has \$224,533.15. Centennial Reserves has \$653,453.29. Total funds \$877,986.44
 - c. Lee provides delinquency overview
- 6) Revitalization Update Lee provides overview that Association received 151 consent forms todate, above the 111 threshold. The attorney has been sent the digital copies for their review and filing of the required documents.
 - a. Board thanks the community for their participation in assuring the governing documents of the Association are revitalized.
- 7) Tree Trimming Update DEO just about finished with pruning. About 5-6 removals are left and they should be complete. DEO trimmed on Nob Hill.
 - a. Discussion of Nob Hill responsibility Sunset Cove v. Jacaranda Master. Lee to clarify with Susan Keane, Master President
- 8) Irrigation issues
 - a. 2nd Street Irrigation issues continue. DEO in community on May 18-19 to review and repair. They did find break at 100482S and repaired it.
 - Board reviewed proposal from JP Electric to move battery operated system for 2nd Street to electric. Electric proposal is first step in conversion. Walt motions to invest up to \$12,000 for electric conversion of 2nd Street irrigation from battery. This includes JP Electric proposal of \$4055.00 and additional investment to DEO for lines and times and City Permit. Vince seconds. Unanimous approval.
- 9) Discussion of Crain Atlantis Engineering Stormwater Review proposal. This is for a review of the drainage system for the community.
 - a. Following Board and community discussion, Nancy motions to accept the \$6300.00 proposal from Crain Atlantis. Walt seconds. Unanimous approval.
